NO ON 74: PUNISHES NEW TEACHERS

- Does nothing to improve public education or deal with the real problems facing our schools.
- Makes it harder to recruit and retain quality teachers.
- Unnecessary! There is already a system in place to fire teachers who are not performing in the classroom.

NO ON 75: SILENCES PUBLIC EMPLOYEES

- Power grab by corporations to silence working people when it comes to the issues that matter most, like pensions, pay and working conditions.
- Unfair! 75 Targets only public employees such as teachers, nurses, police, and firefighters and not corporate special interests.
- Corporations already out-spend unions 24 to 1 in political campaigns. 75 would tilt the playing field even more severely in favor of big corporations.

NO ON 77: WASTEFUL REDISTRICTING

- Just like this special election, this initiative would waste taxpayer money on an unnecessary process.
- Implementation would rely on outdated census data.
- Even Republican Secretary of State Bruce McPherson believes this measure is fatally flawed because it cannot be implemented as proposed.

NO ON 78: DRUG COMPANY SPONSORED "SMOKESCREEN" PRESCRIPTION PLAN

- Put on ballot by drug companies to confuse people intending on voting yes on Proposition 79.
- Drug companies would profit under this plan—not consumers.
- Does nothing to control spiraling drug costs.
