

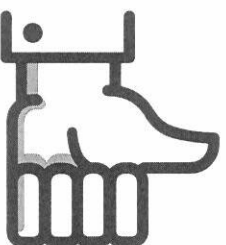

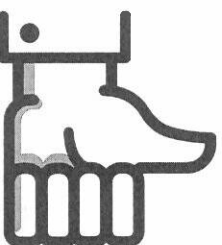

What to do if your pharmacy closes

A pharmacy chain's system is linked across stores. If you want to use the same pharmacy chain, you can go to a different location and tell the pharmacy staff to fill your prescription there.

You may receive a welcome letter from the new pharmacy after your prescription is transferred.

If the new pharmacy is not a SCUFCW Participating Pharmacy, contact your doctor and ask them to send a new prescription to a Participating Pharmacy (see flip side).
